There was continued discussion on the Old Courthouse/New Courthouse. There was discussion on what action should be taken going forward.

Motion by Steffen to adjourn meeting at 4:06 pm and meet again in regular session on Friday, February 6, 2015 at 1 pm and February 20, 2015 at 1 pm, second by Pedersen and called three times for discussion with all ayes, no nays and carried.
