Motion by Wakefield to take a 10 minutes recess, second by Steffen and called three times for discussion with all ayes, no nays, and carried.

Chairman Olson reconvened the meeting and opened the floor to Sheriff Straight to discuss the Barnes County Jail. Sheriff Straight reported about the issues with the Barnes County Jail and if the County would like to discuss building a joint rehabilitation center.

Chairman Olson opened the floor to IT Palm to discuss Server Room Cooling. There was discussion on the options on cooling the server room.

Chairman Olson opened the floor to discuss Tax Forfeited Property. Auditor Larson reported that the City of Cooperstown took the remaining property that was deeded to the City of Cooperstown at the County Tax Sale due to delinquent taxes.

Chairman Olson opened the floor to Old Courthouse/New Courthouse. No discussion.

Chairman Olson opened the floor to discuss future business. The Commission would like to discuss Employee Manual.
