RS/911C Oien discussed the NDDOT letter that he received, and the changes on the Tractor Lease that the Road Department has and what the Commission would like to do for 2016. Motion by Wakefield to approve the 2016 tractor lease, second by Steffen and called three times for discussion with roll call vote: Wakefield-aye, Pedersen-aye, Dahl-aye, Steffen-aye, Olson-aye, and carried.

Chairman Olson opened the floor to the Old Courthouse/New Courthouse. There was discussion on the EOC Grant Funds that the County received. Commission Wakefield reported that he walked through the New Courthouse and everything looked fine. There was discussion on the Water Board meeting in the new courthouse. Motion by Wakefield to take a 10 minutes recess and move into executive session to discuss the litigation on the new courthouse, second by Pedersen and called three times for discussion with all ayes, no nays, and carried.

Chairman Olson reconvened the meeting and opened the floor to the Old Courthouse/New Courthouse. No action was taken in executive session, just an update on the litigation.

Motion by Pedersen to adjourn meeting at 2:31 pm and meet again in regular session on December 4th and December 18th at 1 pm, second by Dahl and called three times for discussion with all ayes, no nays and carried.
