NDLTAP Heglund gave a presentation and there was discussion on PI gravel specs with Gilbertson and Son's being added to the discussion. Motion by Wakefield to take the PI specs from the future gravel contracts, second by Dahl and called for discussion. There was discussion on the motion. Chairman Olson called three times for further discussion with all ayes, no nays, and carried.

Motion by Wakefield to take a 10 minute recess, second by Steffen and called three times for discussion with all ayes, no nays, and carried.

Chairman Olson reconvened the meeting and reopened the floor to Road Superintendent/911Coordinator Oien and KLJ Loegering. There was discussion on the information that was presented regarding Utility Permit. The Commission did not take any action. There was discussion on the future road projects for HB and SB monies. The Commission would like to bid out HB and SB separately. There was discussion on the Engineering Contract and how the Commission would like to go forward. Motion by Dahl to approve the Engineering Contract with KLJ, second by Steffen and called three times for discussion with roll call vote: Wakefield-aye, Dahl-aye, Steffen-aye, Olson-aye, and carried. The Commission would like to bid projects out separately.

Chairman Olson opened the floor to Treasurer Eslinger to discuss the Tax Director's duties.

Chairman Olson opened the floor to discuss the Water Board Appointment. Water Board member Brooks joined the meeting by phone. Motion by Wakefield to appoint Jim Retzlaff to fill Barry Ronningen's term, second by Steffen and called three times for discussion with all ayes, no nays, and carried.

Chairman Olson opened the floor to discuss the Election Meals. Motion by Dahl to approve the purchase of meals for the election workers, second by Steffen and called three times for discussion with roll call vote: Wakefield-aye, Dahl-aye, Steffen-aye, Olson-aye, and carried.

Chairman Olson opened the floor to discuss Canvassing Board Appointment. Commissioner Wakefield volunteered to participate on the board.

Chairman Olson opened the floor to discuss the State's Attorney Secretary. State's Attorney Tenneson discussed his secretary position with the Commission.

Chairman Olson opened the floor to discuss the JDA. State's Attorney Tenneson reported about his research in dissolving the JDA. There was discussion on the motion that was made at the October 21st meeting and tabled. Motion by Wakefield to amend the motion to discontinue the JDA but leave the funds in the JDA account and appoint the County Commissioners to administer that account for a period of two years, second by Steffen and called for discussion. There was discussion on the motion. Chairman Olson called three times for discussion with all ayes, no nays, and carried. Chairman Olson called three times for discussion on the motion as amended with roll call vote: Wakefield-aye, Dahl-aye, Steffen-aye, Olson-aye, and carried.

Chairman Olson opened the floor to discuss Old Courthouse/New Courthouse. There was discussion on a carpenter for the new courthouse. State's Attorney Tenneson will look into the options the County has regarding a carpenter. Auditor Larson reported that all carpet has been completed.

Chairman Olson opened the floor to future business.

Motion by Dahl to adjourn meeting at 3:24pm and meet again in special session on November 15th at 10:30 am and regular session on November 18th at 1 pm, second by Steffen and called three times for discussion with all ayes, no nays and carried.
