Chairman Olson opened the floor to discuss the Server Room. The Commission discussed the information from IT Palm that was presented. Motion by Dahl to instruct IT Palm to proceed with option #2, second by Pedersen and called three times for discussion with all ayes, no nays, and carried.

Chairman Olson opened the floor to discuss Modifiers. There was discussion on what the Commission

would like to do going forward.

Chairman Olson reopened the floor to discuss the New Courthouse Carpentry. Carpenter Craig Stockland called back and will be in Cooperstown so the Commission would like to do a walk through with him during the meeting.

There was continued discussion on Modifiers.

The Commission Meeting moved to the New Courthouse to walk through with Craig. Motion by Wakefield to accept Craig Stockland's Bid of \$80/hr for himself and one helper and to start ASAP, second by Pedersen and called three times for discussion with roll call vote: Pedersen-aye, Dahl-aye, Wakefield-aye, Olson-aye, and carried. Motion by Wakefield to have the employees of the county get paid for a regular day when a storm day is called by the Commission Chair and update the employee manual to that affect, second by Pedersen and called for discussion. There was continued discussion on the issue. Chairman Olson called three times for discussion with roll call vote: Wakefield-aye, Pedersen-aye, Dahl-aye, Olson-aye, and carried.

Chairman Olson opened the floor to discuss Extra Pay. Auditor Larson requested that Deputy Eggermont and Ronnigen receive some kind of bonus pay for the work that was done when Auditor Larson was on leave for medical issues. The Commission is appreciative of the work that they did but can't quantify giving extra compensation for the work that they did.

Chairman Olson opened the floor to discuss December 30<sup>th</sup> Special Meeting. There was discussion on a date that would work best to pay the remainder of bills for 2016. The Commission will have a special meeting on Thursday, December 29<sup>th</sup> at 1pm.

Chairman Olson opened the floor to discuss 2017 Commissioners Meetings. There was discussion on how many meetings the Commission would like to have in 2017. The Commission would like Auditor Larson get some dates together and add the issue to the special meeting's agenda.

Chairman Olson opened the floor to discuss the Old Courthouse New Courthouse. There was discussion on the mechanical work in the new courthouse and moving help. There was also discussion on the light in the Auditor's back room of the new courthouse.

Chairman Olson opened the floor to discuss future business.

Motion by Pedersen to adjourn meeting at 3:50pm and meet again in special session on December 29<sup>th</sup> at 1pm and regular session on January 6<sup>th</sup> and 20<sup>th</sup> at 1pm, second by Dahl and called three times for discussion with all ayes, no nays and carried.
