Vice-Chairman Urness opened the floor for any changes to the agenda. Motion by Pedersen to accept the agenda as presented, second by Wakefield and called for discussion three times with all ayes, no nays, and carried.

Vice-Chairman Urness opened the floor to accept the January 19th meeting minutes. Motion by Wakefield to approve the January 19th minutes as amended and dispense with the reading, second by Pedersen and called three times for discussion with all ayes, no nays, and carried. Vice-Chairman Urness opened the floor to the Monthly Office Reports. Motion by Pedersen to accept the monthly office reports as presented, second by Wakefield and called three times for discussion with all ayes, no nays, and carried.

Vice-Chairman Urness opened the floor to Road Superintendent/911Coordnator Oien. There was discussion on the ND Department of Transportation letter. Motion by Wakefield to sign the NDDOT Letter to extend the inspection cycle for box culverts, second by Pedersen and called three times for discussion with all ayes, no nays, and carried.

Commissioner Wakefield corrected that the bills needed a roll call motion. Motion by Wakefield to approve the bills as presented with the addition of the WorkForce Safety & Insurance bills and execution of the ND Weed Control Association bill, second by Pedersen and called three times for discussion with roll call vote: Wakefield-aye, Pedersen-aye, Urness-aye, and carried.

Commissioner Wakefield reported on the DES Monthly Office Report that he is checking with the State to see if Heartland Consulting's plan will get us back on track with the requirements needed.

Vice-Chairman Urness reopened the floor to RS/911C Oien and Butler Wolford to discuss Road Graders. There was discussion on what the County would like to do going forward. Motion by Wakefield to instruct Wayne to put out perspectives for 5 and 7 year leases on 4 new motor graders and a perspective for purchase of 4 motor graders meeting the specs of the graders we currently have. There was continued discussion on the issue. Motion second by Pedersen and called three time for discussion with roll call vote: Wakefield-aye, Pedersen-aye, Urness-aye, and carried. Vice-Chairman Urness thanked Road Superintendent/911Coordnator Oein for his time and help with this issue.

Vice-Chairman Urness opened the floor to State's Attorney Tenneson to discuss Election. Motion by Pedersen to approve the agreement for State's Attorney Tenneson to run for State's Attorney in both Nelson and Griggs County concurrently, second by Wakefield and called three times for discussion with all ayes, no nays, and carried.

Vice-Chairman Urness opened the floor to NDPERS Representative Schiermeister to discuss the Retirement of the County Employees. Representative Schiermeister reported on NDPERS and there was discussion on the issue.

Motion by Pedersen to take a 5 minute recess, second by Wakefield and called three times for discussion with all ayes, no nays, and carried.

Vice-Chairman Urness opened the floor to discuss the Employee Manual. The Commission tabled the issue until Commissioner Olson can be at attendance.

Vice-Chairman Urness opened the floor to discuss the Abatements. Motion by Wakefield to approve the abatements as presented, second by Pedersen and called three times for discussion with roll call vote: Wakefield-aye, Pedersen-aye, Urness-aye, and carried.

Vice-Chairman Urness opened the floor to discuss the Garrison Diversion Letter. The Commission would like the letter forwarded onto the Cities and the Historical Society.

Vice-Chairman Urness opened the floor to discuss the Court Facilities Grant. No action was taken.

Vice-Chairman Urness opened the floor to discuss the old courthouse new courthouse. There was discussion on the old social services building and that there was an unformal offer made to the County. Motion by Wakefield to have the realtor reduce the price to \$40,000, second by Pedersen and called three times for discussion with all ayes, no nays, and carried.

Motion by Wakefield to adjourn meeting at 3:10 pm and meet again in regular session on February 23rd, 2018 at 1 pm, second by Pedersen and called three times for discussion with all ayes, no nays and carried.
