Chairman Olson opened the floor to review Monthly Office Reports. Motion by Steffen to accept the monthly office reports, second by Pedersen and called three times for discussion with all ayes, no nays, and carried.

Chairman Olson opened the floor to discuss the Covid-19. There was discussion on the Future Commission Meetings and how they will work going forward. Auditor Larson is working with IT Palm and hope to have something better by next meeting. Nelson-Griggs Health Unit Ferry gave the Commission an update on what her office has been doing as far as preparation. DES Hanson gave an update as well. Auditor Larson also discussed with the Commission about updating laptops within the Courthouse to have Windows-10 for working from home if needed for the Auditor and Extension office. Motion by Wakefield to approve the purchase of the updated laptops and will discuss what accounts to take them out of when the invoices come.

Chairman Olson opened the floor to Road Superintendent/911 Coordinator Oien and KLJ Bjornson. There was discussion on the information that was presented. Motion by Steffen to approve the final review and acceptance and the progressive estimate from Tom Gilbertson & Sons, second by Pedersen and called three

times for discussion with roll call vote: Wakefield-aye, Pedersen-aye, Urness-aye, Steffen-aye, Olson-aye, and carried. There was discussion on the Dekker Bridge and what the County would like to do going forward. Motion by Pedersen to have KLJ inspect the Dekker Bridge, second by Wakefield and called three times for discussion with roll call vote: Wakefield-aye, Pedersen-aye, Urness-aye, Steffen-aye, Olson-aye, and carried. There was also discussion on options for future road projects if funding becomes available from the State.

Chairman Olson opened the floor to discuss the Soil Conservation Mill Levy Mistake. There was discussion on the mistake that Auditor Larson had made regarding the mill levy shortage for the Soil Conservation. Soil Conservation Johnson joined in the discussion. State's Attorney Tenneson recommended that the Commission do nothing and wait until next year to levy the money. Motion by Wakefield to abide by State's Attorney Tenneson recommendation and do nothing this year, second by Steffen and called for discussion. There was continued discussion on the issue. Chairman Olson called three times for discussion with roll call vote: Wakefield-aye, Pedersen-aye, Urness-aye, Steffen-aye, Olson-aye, and carried.

Chairman Olson opened the floor to discuss NDSU Extension. There was discussion about the NDSU Extension Agent issue to be put on the ballot as an Advisory Measure for the voters to decide if they would like to fund an Extension Agent up to 4 mills. Motion by Wakefield to put an advisory vote on the ballot for the June Election regarding the NDSU Extension up to the maximum, second by Urness and called three times for discussion with roll call vote: Wakefield-aye, Pedersen-aye, Urness-aye, Steffen-aye, Olson-aye, and carried. There was discussion on giving NDSU the go ahead to start the hiring process for a full time agent. Motion by Urness to instruct NDSU to begin the hiring process for a full time Extension Agent, second by Wakefield and called for discussion. There was continued discussion on the issue. Chairman Olson called three times for discussion with all roll call vote: Wakefield-aye, Pedersen-aye, Urness-aye, Steffen-aye, Olson-nay, and carried.

Chairman Olson opened the floor to discuss the 2020 Primary Election. There was discussion on if the County would like to be Absentee Ballot exclusive and not have a polling site. Motion by Urness to only have Absentee voting for the Primary and close the polling place, second by Pedersen and called three times for discussion with roll call vote: Wakefield-aye, Pedersen-aye, Urness-aye, Steffen-nay, Olson-aye and carried. There was discussion on poll worker pay. Auditor Larson recommended increasing the pay from \$10hr for clerks and judges and \$10.75 for inspector to \$12/hr for clerks and judges and \$12.75 for inspector and provide meals. Motion by Urness to go forward with Auditor Larson's recommendation, seconded by Steffen and called for discussion. There was continued discussion on the issue. Chairman Olson called three times for discussion with roll call vote: Wakefield-aye, Pedersen-aye, Urness-aye, Steffen-aye, Olson-aye, and carried.

Chairman Olson opened the floor to discuss the Red Willow Ministries Local Raffle Permit. Motion by Pedersen to approve the raffle as presented, second by Urness and called three times for discussion with roll call vote: Wakefield-aye, Pedersen-aye, Unress-aye, Steffen-aye, Olson-aye, and carried.

Chairman Olson opened the floor to discuss 2020 primary ballot measures. Auditor Larson reported that any other ballot measures need to be to her office by 4pm on Monday, April 6th.

There was continued discussion on the NDSU Extension Agent. Commissioner Steffen recommended that the County should request an agent with a strong 4H background and have at least 3 years of experience. The Commission would like Commissioner Steffen to be the liasion on the issue. Motion by Wakefield to accept Commissioner Steffen's recommendations, second by Steffen and called three times for discussion with roll call vote: Wakefield-aye, Pedersen-aye, Urness-aye, Steffen-aye, Olson-aye, and carried.

Chairman Olson opened the floor to discuss Old Courthouse/New Courthouse. Auditor Larson reported on the County Property Auction list that is still in the works. Commissioner Urness also reported on the Chandelier that the Courthouse will be inheriting.
