Chairman Olson opened the floor for any changes to the agenda. Motion by Pedersen to accept the agenda as presented, second by Steffen and called for discussion three times with all ayes, no nays, and carried.

Motion by Urness to approve the Construction Engineering Service Agreement for LPA Federal Aid Project for project SC-2003(061), second by Pedersen and called three times for discussion with roll call vote: Wakefield-aye, Pedersen-aye, Urness-aye, Steffen-aye, Olson-aye, and carried. There was discussion on the change order for project CNOB-CNOC-2026(058) that was presented. Motion by Pedersen to approve the Change Order for project CNOB-CNOC-2026(058) as presented, second by Steffen and called three times for discussion with roll call vote: Wakefield-aye, Pedersen-aye, Urness-aye, Steffen-aye, Olson-aye, and carried. There was discussion on the Amendment of Engineer-Owner Agreement that was presented. Motion by Urness to approve the Amendment to engineer-owner Agreement for project CNOB-CNOC-2026(058) PCN22454, second by Pedersen and called three times for discussion with roll call vote: Wakefield-ave, Pedersen-ave, Urness-ave, Steffen-ave, Olson-ave, and carried. Motion by Pedersen to approve the payment to Dahl Consultants for the hydraulic study, second by Urness and called three times for discussion with all ayes, no nays, and carried. Motion by Pedersen to approve the reimbursement request for project CNOB-CNOC-2026(058), second by Steffen and called three times for discussion with all ayes, no nays, and carried. There was discussion on the abstract for the property in Binford where the new County Road Shop will be built. There was also discussion on the gravel on County Road 21 that was discussed at the last meeting.

Motion by Wakefield to recess the regular meeting and enter into Tax Equalization, second by Steffen and called three times for discussion with all ayes, no nays, and carried.

Chairman Olson called to order Tax Equalization and opened the floor to Tax Director Lunde. There was discussion on the NDCC 57-12 & 11-10.1 and what/who the County needs to go forward with Tax Equalization. There was discussion on how Tax Director Lunde came up with values within the townships that he assessed and what he recommends the County does to go forward to equalize the County as a whole. Motion by Steffen to recess the Tax Equalization Board, second by Wakefield and called for discussion. There was discussion on property that was eliminated or added since equalization and if the Commission would like to take action on this or table until the next meeting. Chairman Olson called three times for discussion with all ayes, no nays, and carried.

Chairman Olson reconvened the regular meeting and opened the floor to County Property. Motion by Pedersen to sell the property (Lots 17-20 Block 37) to the City of Cooperstown, second by Steffen and called for discussion. There was discussion on what the motion needs to entail. Motion by Pedersen to amend his motion to include abating the taxes on the property and selling it to the City of Cooperstown, second by Steffen and called three times for discussion with all ayes, no nays, and carried.

Chairman Olson opened the floor to discuss the 2018 Audit. There was discussion on the information that was presented. The Commission would like Auditor Rotunda to move forward with finalizing the Audit.

Chairman Olson opened the floor to discuss the Engineering Pool. There was discussion on the issue and how to move forward with it in Griggs County. State's Attorney will continue working on this.

Chairman Olson opened the floor to Old Courthouse/New Courthouse. No discussion was held.

Chairman Olson opened the floor to discuss future business. There was discussion on Budget that will be on the agenda next meeting.

Motion by Steffen to adjourn meeting at 5:17 pm and meet again in regular session on June 21<sup>st</sup> at 2:30 pm, second by Urness and called three times for discussion with all ayes, no nays and carried.
