Chairman Olson opened the floor to discuss the 2018 Budget. There was discussion on the budget forms that Auditor Larson has received back at this time.

Chairman Olson opened the floor to discuss the Tax Director. There was discussion on the meeting with the State Tax Commissioner that was held earlier today. Motion by Wakefield to send a letter by certified mail to the State Tax Commissioner in response to the meeting as follows:

"Ryan Rauschenberger State Tax Commissioner Following the hearing (In the matter of the review of the Griggs County Sales, Market, and Productivity Study) the Griggs County Commission has voted to comply with the provisions of 57-01-07(1) using the best information available at this time and taking into account the factors of equalization as the Commission understands them to be. Troy Olson Griggs County Commission Chair".

There was continued discussion on the issue. Motion second by Pedersen and called three times for discussion with roll call vote: Wakefield-aye, Pedersen-aye, Dahl-aye, Steffen-aye, Olson-aye, and carried.

There was discussion on the Sales Ratio Study and what information the Commission would like to include. Motion by Wakefield to have the County Commissioners resign as the interim Tax Director, second by Dahl and called for discussion. There was discussion on advertising for the position and the motion on the table. Chairman Olson called three times for further discussion with all ayes, no nays, and carried. Motion by Wakefield to readvertise the Tax Director position in the Griggs, Foster, Nelson, Steele, and Barnes County newspapers, second by Steffen and called three times for discussion with all ayes, no nays, and carried.

Chairman Olson opened the floor to Old Courthouse/New Courthouse. There was discussion on winterizing the old courthouse. The Commission would like Auditor Larson to talk to Custodian Pfeifer about getting everything shut off and discuss the draining of domestic water.

Chairman Olson opened the floor to discuss future business. DES positon will need to be discussed in the future.

Motion by Steffen to adjourn meeting at 2:48 pm and meet again in regular session on Friday, July 21, 2017 at 1 pm, second by Pedersen and called three times for discussion with all ayes, no nays and carried.
