School board members joined in the discussion on how this affected the school.

Chairman Pedersen opened the floor to discuss the COVID Funds. Auditor Larson reported that the County has received half of the COVID funds that were available to the County and further explanation of how those funds can be used will be presented when it becomes available.

Chairman Pedersen opened the floor to discuss the Tax Director Position. Commissioner Edland had to leave the meeting. The issue will be tabled until the next meeting.

Chairman Pedersen opened the floor to discuss Old Courthouse/New Courthouse.

Chairman Pedersen opened the floor to discuss future business. The Commission will discuss Tax Director and GIS at the next meeting. There was discussion on the GIS program the County uses for it.

Motion by Tranby to adjourn meeting at 3:28 pm and meet again in regular session on September 23<sup>rd</sup> @ 2:30 pm, second by Wakefield and called three times for discussion with all ayes, no nays and carried.
