Chairman Olson opened the floor to discuss the 2020 Budget Calendar. There was discussion on the calendar that was presented and also what the Commission would like to use as a COLA increase.

Chairman Olson opened the floor to discuss the Ameripride Service Agreement. Motion by Steffen to approve the Ameripride Service Agreement as presented, second by Urness and called three times for discussion with all ayes, no nays, and carried.

Chairman Olson opened the floor to discuss the Old Courthouse/New Courthouse. There was discussion on the County Auction that was discussed at an earlier meeting.
